


KM-LOTO

- Clear out the throat first.
- Tilt head back.
- Fit mask firmly on the face.
- Squeeze the ball.
- Watch the chest. It should rise and fall smoothly.
 - If the chest does not rise and fall smoothly, there may be blockage in the victim's throat. The tongue has obstruct the airway.
- OR
- There could be excessive leakage around the mask. Hold the mask tighter on the face and squeeze it little faster.
- Clear any mucus from the throat every 3-4 minutes.
- Continue RESUSCITATION until the victim starts breathing naturally.
